## **Open Comments**

- We had a good thing by being part of unincorporated DeKalb County. Taxes were reasonable, services were good. I think we should work to clean up corruption and improve what we have. I don't think we should add another layer of government, whether it be as a new city or by being annexed into Atlanta. I am happy with many of the DeKalb County services. We have very good garbage pickup, recycling, yard waste pick up, etc.
- Thanks for requesting my thoughts. My negative feelings about cityhood, I will admit, have been further cemented by my parents' owning a house in the City of Brookhaven. It may be the nature of small cities to spawn small-time politicos who can create all manner of petty issues to squabble over. I definitely do not favor an additional layer of government, and that is largely what cityhood would mean. And we'd still have DeKalb County government too. P.S. I feel compelled to add that the cityhood movements beginning with Sandy Springs and Dunwoody were largely motivated by thinly disguised racism and social elitism. Look at the shakers and movers for any of these cityhood movements so far. how many minority representatives does one find? Do we want to be associated with such a movement? I do not.
- (1) When the cities in North Fulton incorporated, it was because the residents believed their taxes were disproportionately allocated to South Fulton. I haven't heard similar complaints around here. (2) Some of the new cities ??? Virtually all city operations except police. They are now finding it not so affordable. (3) DeKalb Co. government is relatively efficient certainly more so than Atlanta. What do we gain by incorporating?

Manuel Maloof had it right 25 years ago: City of DeKalb (all of it). Disagreement should lead to arbitration before a political state appointed group is used. Politicians have an established record of destroying community for political gain.
- To date, none of the new cityhood initiatives have offered specific plans to address issues like policing and infrastructure. Without any idea of what the plans are, there is no way to determine the real consequences of cityhood.
- I and my husband are totally 100% opposed to any change from unincorporated DeKalb County. Want status quo please!

If DeKalb County plans to incorporate all unincorporated portions of the county, this needs to be added to the conversation so that residents understand that incorporation might be inevitable and so that we can start to look more realistically at what our future options are.

We have six children attending DHMS and DHHS. The loss of the STT program at Fernbank and the International Baccalaureate at DHHS would be tragic for our children. If DeKalb County Schools could present the plan for our children's education, it would help us make a better decision. however, without the knowledge about schools, we have to choose to go with Druid Hills because it is the only known quantity. I own two properties in the Laurel Ridge attendance zone and have only recently recovered from the losses suffered under the financial crisis. I am so scared of having our property values devastated again by these changes.
- The number of depressed and run-down areas is rising as businesses and residents leave for better locations. These moves result from poorly run gov't and school systems and increasing taxes. Also robberies are on the rise, at least in this area. There are many empty businesses and houses which contribute to attracting robbers. Improvements must be made regardless of the option.
- I have lived on the corner of Wilson Woods and Shetland Dr for 53 years. 5 of our children went to Laurel Ridge School and Shamrock High School (which now does not exist.) Our oldest child went to Druid Hills High. I am perfectly satisfied with DeKalb County. We do not need to belong to Atlanta with higher taxes and more crime. Nor do we need to be a New City.
- We're older, no children in school, satisfied with present community conditions. Highly desirable to maintain affinity with Emory/CDC.
- Not sure really there are too many unknowns want to keep Decatur address despite not being in "City of". I do NOT want to be a part of Tucker.
- Annexation may benefit Atlanta and specific neighborhoods but will diminish DeKalb Cty w/o
  providing benefit to the greater area. Cityhood is the best trade off to offset a diminished
  DeKalb Cty. While not taking anything away from Atlanta.
- Not interested at all in joining City of Atlanta. There is a sense of urgency regarding the
  cityhoods right now and people are having to make a lot of reactionary decisions based on
  fear. My main concern is that we could potentially be trading the devil you know for the devil
  you don't know. DeKalb County was fabulous once. What is going to stop these cities from
  decline? Why can't we fix DeKalb County?
- Having worked in the City of Atlanta for almost 45 years, I interacted with city officials most of

- that time. The problems DeKalb has experienced in recent years are nothing compared to issues in the city and their mgt.
- The only reason I would want to join a new city is that it seems much of the rest of the county is being incorporated. I don't want to be the last community in unincorporated DeKalb County.
- We definitely do not want to be part of City of Atlanta -- Definitely think cityhood will increase taxes. Thank you for doing this survey!
- I would prefer LaVista Hills over Atlanta.
- Could not answer ranking because of too many unknown factors. We appreciate the work being done to make sure the information is provided to us. The more we know the more we are able to move forward to a decision.
- Get it Done!!
- I'm strongly opposed to losing DHMS/DHHS to City of Atlanta!
- Has anyone considered a City of Druid Hills? I would feel at home there. I feel that the overriding issue is the fate of the Druid Hills cluster of schools. Families have moved into this area because they want their children to go to Druid Hills High. This attraction affects all property values, even of those homes that have no children in school. No part of the cluster should feel comfortable about splitting it up for the sake of one or two feeder schools. If DeKalb County wants to retain this attendance area, the School Board should be required to reconsider the cluster proposal. The other important issue relates to how hard it is to reach a consensus. This takes time and a willingness to listen to opposing views. Many of us have felt pushed, without any input, to join a new city without enough time to consider all the ramifications. Pushing for a decision without taking time to grow a consensus is at the root of many problems, including distrust of whatever governance is put into place hastily. Most importantly, the discussions must remain civil. Thank you for providing a means to be part of the discussion.
- Thank you for gauging the community members' pulse on this topic.
- Higher quality of Life with independence of schools and increased voice in governance.
- I would like to have the schools just the way they are. I don't want them to annex. Keep our schools where they are! Thank you.
- If Atlanta takes over Druid Hills High School, what happens to all the kids that would have gone to high school there? You'd be leaving them high & dry! All residents of DeKalb County should get a vote, because everyone's affected by the creation of a new city,, whether or not they actually live in it. If the county has to raise taxes to make up for the lost revenue, everyone's affected & should therefore have a voice. It seems so many people object to big government. Why do they want to add another layer of government when they'll still have to pay county taxes? Seems like too much power in too few hands.
- Cityhood claims movement is about "the people". Yet decisions are made by a small group of people behind closed doors by elected officials we can't vote for. Tired of hearing this inevitable. Many don't want this or trust those pushing it on us. This is a local issue & should be decided locally. Not by those we can't vote for. The energy put into cityhood should have put into making county better/less corrupt. If this happened, many would feel cityhood pushers were more genuine. Right now they seem power hungry. Schools are huge. Why is our school board rep not fighting for all children he represents? Why does Fernbank get High School when they have 2/5 of students for it? Loosing Druid Hills High School would be a great loss to our community. What will DCSS do? Citizens need to learn more about Blueprint & work with elected officials to make necessary changes to improve DeKalb. We also need to support better candidates across the county.

- Great job with the civic assoc. Long overdue!!
- Would like more info -- I'm still confused about the advantages for joining a new city. Thanks
  for our hard work trying to get us more informed!
- I think it would be best to stick with Emory and whichever direction Emory goes in. Also with Farmer's Market and other businesses. Do not want to be left out in the cold-- with no business tax benefit. Why not remain unincorporated all round &make it work (remove the corrupt officials etc) Again. Do not want to be left isolated in pocket w/no business tax revenue, gov. services, etc (police etc) Stay unincorporated, clean up what's not working & be a better DeKalb.. This is all very fuzzy. Clearly no one wants to be left out in an isolated pocket of unincorporated DeKalb without effective Police service, etc and lose property value. We have excellent residential locations here and should be respected for maintaining our properties. it is essential that no one suffer being left out and lose community services & financial value.
- Druid Hills High School has not been our #1 choice for our children so if they choose to join Atlanta, it would not affect us. Our main concern is safeguarding the quality of life in our Laurel Ridge-Shamrock district in whatever manner possible be it improving the County we currently live in.
- On moratorium Sandy Springs studied it for 15 years. This process is reactive, not strategic. It still does not fix problem. Dekalb form of gov needs to change or ALL of DeKalb needs to municipalize. I worked at the Atlanta Regional Commission of 11 yrs as Division Chief of Local Government. I was deeply engaged in the before and after of the creation of all North Fulton cities. I currently work in Gwinnett as Director of Econ. Development and have been engaged in Peachtree Corners. I would like to be part of this effort and offer resources and references as we move forward.
- We are VERY concerned at what seems a grab of the best schools, incluing our HS by wealthy, white Druid Hills residents. Frankly, it is infuriating and while we had opposed a new city we now feel strongly that active overtures need to be made to join the Atlanta annexation initiative.
- I have dealt with some of the new cities and have been impressed. We need overall regional planning for major issues such as traffic and water. I agree that some latitude should be given to local school clusters. The only exception to this has been the city of Decatur.
- If possible I would appreciate hearing an apples-to-apples comparison of the various alternatives. (I realize this would not be easy.)
- Will look forward to more information. Did the legislators tell us to do this? Why started?
- Thanks to all you busy neighbors who are making time to address these important issues. You
  are appreciated.
- I prefer to remain unincorporated!
- no comments
- Since cityhood seems to be inevitable, we would prefer to be part of a known long-established city than a new one. There are already too many county and municipal governments stirring the pot.
- Not sure. have not seen much positive from DeKalb Co. I work in Doraville/Chamblee area and see positives of presence of Chamblee police. Regardless of what happens, we will live in DeKalb County. DeKalb County Government MUST improve!
- We would like to see the "Blueprint for DeKalb" process bring about positive change for the whole county, rather than creating more small municipalities.
- Just want to work on getting DeKalb better

- I would like to be in the new city if funding for education was a priority. I don't think remaining unincorporated would solve education funding and if the county still won't let charter clusters form then the schools will remain underfunded.
- Thank you for taking the time and effort to facilitate this input!
- What's the big rush? I don't have enough info/understanding to intelligently respond. My responses are based on gut. I want to understand why something like Jacksonville FL/Duval County doesn't work: one level of government & one level of taxes & (by George!!) the right hand knows what the left hand is doing. (Caveat: I don't know/understand if Jax/Duval Co. works well but it makes sense to me!!)
- We strongly oppose annexation and cityhood. With either option, we would still be a part of DeKalb County. Annexation and cityhood would not fix the problems with DeKalb, and it could potentially create new problems. Working together to fix DeKalb is our best option.
- For question 12: or Permanently dismiss all movements towards cityhood & annexation. State legislators waste enough time without tossing this issue in. I would be part of a group that forms to oppose cityhood and annexations.
- There are absolutely zero parks & recreational facilities in the current boundaries. The boundaries are awkward, there is no city center. Areas outside of 285 (a physical boundary) should not be included in the boundaries. The name "LaVista Hills" sound like a retirement community. As millennials, we want to live in an area that is thriving, and has potential for growth. We like saying "I live in north Decatur." No one will know & recognize the "LaVista Hills" name. Why not just be "North Decatur"?
- Would choose being annexed to Decatur City of over Atlanta or New City.
- We should stay unincorporated.
- We worry the results of this survey may be misinterpreted. We answered the questions as best we could but can't say how we would ultimately vote. Our preferences will be strongly affected by what other cities and communities do or try to do. The survey starts with the assertion that there are only three realistic options and asks us what we think of only these three options. Other potential sentiments (for example, annexation into the city of Decatur; a one-year moratorium on incorporation; or choosing affiliation based on the ultimate affiliation of surrounding neighborhoods or commercial properties like N. DeKalb Mall) are not ranked, so a survey answer may imply falsely that one of the three options is a respondent's first choice. The truth is, we are incredibly ambivalent and conflicted about all these choices. One of the purposes of this survey is so that we can lobby state legislators to keep Decatur, Atlanta, or Emory University from behaving badly. For instance, if Decatur is going to poach the commercial properties around our neighborhood, they should be required to support the surrounding residents as well. If Atlanta is going to get prices resources from DeKalb School System, they should be required to compensate the school system in some way. Regardless of court precedents, the legislature has the power to change the rules as part of any annexation deals, so some form of compensation should be a condition of annexation if Druid Hills joins Atlanta.
- Support the moratorium IF agreement cannot be reached. The school situation is difficult for
  us as we did not have children but, we hear complaints from parents who have children in the
  local schools. Many are in private schools. DeKalb has been on the wrong road for a while now
  and something needs to be done.
- It is incredibly selfish & unjust to want to incorporate in an effort to take resources out of the larger DeKalb Co. area. As the snow storms of Jan/Feb of this year showed, those who were part of an incorporated city fared much worse than those who were part of DeKalb Co. To

think that taxes will not go up w/incorporation is ignorant. To think that schools will benefit from joining Atlanta Public Schools is ignorant. To think that by incorporating/annexing will "protect" us is selfish, unjust & ignorant. If we have to be annexed by anyone, it should be city of Decatur. That is where we live.

- Surely, none of you would consider merging with Atlanta Just start reading the newspaper.
- Support one-year PLUS moratorium.
- This is very confusing and I seem to get different information from different sources. I would really like to see changes in the ethics of our Politicians and then I might be more inclined to join a particular group. Everything seems so self-serving. Where has integrity gone.
- Would choose to remain unincorporated only if schools including High School would remain.
   Making small school systems lessens resources to students in many ways (see New Orleans school reports). I am concerned about DHHS the property belongs to Emory and so it seems that the school would have to go where Emory goes.
- The thought that taxes would not increase for a new city are unrealistic. The idea of multiple cities within DeKalb Co. appear to be to be racial. We should be doing more to promote a good school board and county gov't rather than breaking away into an enclave.
- DeKalb County politicians have squandered/wasted our tax dollars. 4 out of every 10 kids in DeKalb County public schools fail to graduate from high school. Our streets are littered with pot holes. Our parks are neglected. Too much petty crime in our NHoods. Businesses are leaving the area @ alarming rate.
- No New Cities! Let's at least slow down and not rush into it. No new cities! No new cities! This process needs to slow down! We all need to be informed and to be able to weigh all options. This should not be strong-armed through the legislature by a few people! Why are we not talking about what happens AFTER the vote? What will schools look like? Who will be the teachers? Services?
- Druid Hills School cluster should be staying in part of DeKalb County unincorporated.
- We have too many county & local gov'ts that fail to deliver services. The answer is to improve existing infrastructures and participation therein: not create more duplication & miss on economies of scale. We already have roughly twice as many counties as FLA with half their population. So more smaller govts, & their admin costs, are not the answer.
- We fundamentally believe that the current atmosphere which exists in DeKalb County to establish new cites derives from mistrust and frustration with the school system. This movement, which also exists in neighboring counties, seeks to unify more exclusive type neighborhoods into city structures who will have greater control overt their school systems. Unfortunately this mind set does not take into account the long term ramifications which will ultimately arise. It's easy to come out at this point and assure residents that taxes will not go up and police and fire services will not be affected, but in the end we believe that the taxes will have to go up and the police and fire services will be drastically impacted in a negative direction. Dividing DeKalb up into several smaller city units will end up weakening the county, including the services it provides, and will necessitate the creation of many smaller less functional school, fire and police entities. In the end, this results in more government and more funds needed to facilitate these new government agencies. Atlanta is a very unique city in the sense that outside its city limits lie many small city structures who long ago decided not to annex land. This created the large unincorporated areas such as exist in DeKalb County. Almost all other major cities throughout the country are not like this. When leaving one city, in a metropolitan area, you enter into another city. These suburban cities, which are well established, have enough citizens to support schools, fire and police services and parks. The

current ideas being discussed today in the Atlanta area are far too late in the coming and will ultimately be very costly for the tax payers. We also find it somewhat ironic that so many who support these types of ideas tend to those with conservative values which strongly advocate less government. Dividing DeKalb County up into several new small city units will create animosity, greatly impact property values in both directions, negatively impact fire and police services and will increase taxes for needed funds.

- DeKalb County should focus on getting county government on solid ground (ethics, schools, budget, county services). Don't know enough background as to why this issue is so important right now nor do I know what Gannon's Blueprint to Redefine DeKalb includes. A clearer understanding might change my opinion, but for no I approve remaining unincorporated.
- If we can form a city government which provides same or better services with no increases in tax then I'm all for a new city, providing that we can gain control over the schools and increase rigor.
- I worry that the decision is being made out of fear and sense of need instead of from a position of knowledge.
- I do not want to have my property value decrease because of the annexation!!!
- Give the homeowners in the LaVista Hills area an opportunity to self-govern. We have been ignored and deceived by recent county leadership! (Jones & Ellis administrations in particular.)
- LRSCA should be working with the proponents of LaVista Hills or the city of Briarcliff. We
  endorse LaVista Hills or annexation into Decatur. Decatur needs the tax base & the school
  bldgs we can bring to it.
- Would prefer it [Druid Hills school cluster] broken up to joining City of Atlanta. We don't like
  the name "LaVista Hills". How can we get a better name? How about "North Decatur"? Also it
  seems like us bracketing off the issues of SCHOOLS & TAXES from the decision when these are
  probably the top two concerns for most people in the area.
- County government isn't going away another layer of government. Just invitation to more problems. By all means stay out of Atlanta!
- Resubmit school cluster proposal or take it to state board of education. Find way for Emory to go into Atlanta so Druid Hills can stay in DeKalb either new city or remain unincorporated.
- Thank you to all the Laurel Ridge Shamrock Civic Assn Board members for your efforts and hard work. You are building a strong bond among the community!
- Do not rush to a decision just to decide. SLOW DOWN!!! THE PROCESS.
- The amount of information supplied here is actually not substantial enough to make any kind of truly informed decisions. Not sure what constitutes Clairmont Hts.
- I have lived in the City of Atlanta and for 6 years owned property in Atlanta in DeKalb County.
  Property taxes increased greatly over those 6 years and I moved to unincorporated DeKalb.
  My taxes decreased and services increased when I got out of Atlanta city limits. At that time schools in DeKalb were good and, after the APS scandal probably still are better than Atlanta's.
- My 2 biggest concerns are: (1) The school cluster I teach at DHMS, so I have a vested interest here. (2) Taxes I'm not convinced that lower taxes or no/low increases are truly viable.
- I do not understand what the implications of a one year moratorium would be. Why not direct our energies toward improving DeKalb County schools & services, instead of the proposed new cityhood.
- While my children will have graduated from Druid Hills HS by the time these initiatives are completed, I am concerned that property values and interest in this neighborhood will decline significantly if we lose the cluster of Druid Hills schools. Maybe the City of Atlanta should

- include everything inside the perimeter, if they are trying to expand, not just "cherry pick" the cream of DeKalb County. Although I'm not a huge fan of City of Atlanta, maybe it wouldn't be the end of the world.
- WHY are the planners and decision makers of LRSCA hopping up and down to jump on board the cityhood annexation train so passionately and hurry up & make a decision?? Making a decision in a RUSH Is the WORST think anyone can do. You are sending out these surveys and asking for them back in only days, etc. WHY? Stop buying into the fear mongering and just step back and chill out for a minute and realize that we have options. We do not HAVE to make a decision here. But hurrying up and making the WRONG decision just to say we've made one is a very bad idea.
- We're intrigued by cityhood, but there are many unanswered questions with regard to schools, police, etc. Needs to be a transparent and uncorrupt process. Thanks!
- For question 4:Oppose both! Neither is my choice. No preference implies that I don't care which one, which is untrue. So, I gave my answer. Also, why isn't joining Decatur a hypothetical choice? I'm disgusted that a seeming minority of Republicans on the north side ofour area got this cityhood ball rolling. They've no real concern for the unincorporated area South of them. They just want population and commercial properties for their "city". I enjoy being unincorporated, which was my financial choice. Why is my choice now being ??? and in the name of "local control"? Also, the cityhood effort hasn't thought through how their efforts may wreck our schools, which are very good ones. Imagine if all this cityhood effort went into reforming DeKalb County.
- We purchased our home in Country Squire three years ago SPECIFICALLY because it was in unincorporated DeKalb and because it was zoned for Druid Hills High. We also own and have lived in City of Atlanta. The services we receive from DeKalb Co. are far superior. We find the cityhood/annexation issues to be divisive within the community, which is the exact opposite result it should have. A cluster of neighborhoods/subdivisions with no city center does not make a city. to date, we have heard no compelling reasons for cityhood. The only reason we would support C o A annexation is to keep our schools together.
- Biggest concerns are deterioration of our schools and much higher taxes. It remains unclear to
  me how becoming a new city or Atlanta will change funding to our schools. I think it would be
  very helpful for residents to have a clear breakdown of how schools, police, roads and taxes
  would be effected by becoming a new city or Atlanta. I need more information before I can
  make an educated decision.
- Do whatever Emory & Fernbank do. Go with the \$\$\$\$\$\$ check. My child attends the Globe Academy, which only serves those in unincorporated DeKalb County...
- The problems I have with the county -- corrupt govt officials and a failing school system will not be fixed by cityhood. I will ONLY favor cityhood if incorporating a new school system is made part of the deal Police and other services are fine the way they are.
- I think it's dangerous for our communities to leave decisions about our future in the hands of state legislatures. These decisions need to be addressed locally. I think we would be better served investing our energy in addressing the issues of concern and trying to reform things within the current system. Incorporation seems to be a band aid that may produce some benefits in the short-term, but will the benefits be sustainable long-term?
- We should clean up the government we have now instead of hiding it behind another layer of
  dysfunctional government. I also object to your use of the term "decision maker" in this
  question. WE THE PEOPLE should be the "decision makers"! Also, only providing 5 days to
  respond to this survey is insane if you want participation from more people.

- People have chosen to reside in unincorporated DeKalb for many reasons. There are no
  pressing issues, in my opinion, that require incorporating us into a city. A tremendous amount
  of money will be spent if this is pursued without an equal payout. The cost benefit is lacking.
- Like many people, I quite frankly don't understand nor concern myself with most of these issues. It would be nice if our governing officials would conduct themselves appropriately as civil servants to protect and serve the citizens of our community.
- It's a huge waste of energy and resources. Focus on solving the community's problems rather than bickering about 'city' hood.
- There are way too many unseen collateral consequences of annexation and incorporation of ALL parties. We need to be able to figure out what those are before it is too late. Thus, the moratorium. We bought our home because it was NOT in a city. I want it to remain that way. Let's fix DeKalb.
- I am extremely unhappy and disappointed with the Druid Hills Atlanta annexation discussion. This seems very self-serving by a few individuals. The City of Atlanta has never struck me as a good steward of public schools. I understand the frustration with DeKalb Co. and wish the county was more responsive to ALL its citizens. I am disappointed in the way this has come about. I appreciate the opportunity to be heard. I would like to stay unincorporated and for DeKalb County to be better stewards of us.
- Cityhood worries me. I feel much of the turn away from DeKalb county is due to the current corruption and mismanagement w/County & schools. I feel a "breather" should be put in place to let emotions cool and give the County & citizens a chance to fix the issues that have greatly exacerbated the emotions of DeKalb citizens. BUT if we'd have to go somewhere, I'd rather be brought into Atlanta than to attempt to create a new city. I believe strongly that our taxes would be exorbitant if we were to attempt cityhood on our own.
- Out of our diversity comes our strength. Do not dilute it. Thank you.
- For us, what is driving our preference is our schools. We feel it is crucial to keep our school
  cluster united and our "neighborhood" schools viable. Good education offering is the key to
  any successful community.
- New city would insure we would receive greater value for our tax dollars -we would not have the unprofessional leaders taking from our tax dollars & converting to their use--
- As I said, I want a Decatur mailing address.
- DeKalb County management is a mess. If a jury cannot reach a verdict because they feel sorry
  for the defendants twin sons and wife what chance do we have for improvement. To do any
  business in Atlanta would be an impossible task.
- Want a ten-year moratorium. I am not interested in becoming a new city nor being incorporated into ATL. Stay unincorporated DeKalb. Please leave us unincorporated. Brookhaven & Sandy Springs have had significant growing pains & corruption in BOTH already. No benefit to options provided. Who is behind pushing these changes and why are changes necessary? Why can't we stay as unincorporated DeKalb? Who is benefitting if we join ATL or form a new city?
- I feel very strongly against the annexation into the City of Atlanta. I have many concerns about the whole thing in general (property value, taxes, schools). With 2 kids in the magnet program, I would be VERY UPSET if they can no longer go to their current schools.
- I don't think this (Laurel Ridge Shamrock cannot consider annexation into Atlanta until neighboring Medlock and Clairmont Heights Communities have agreed to it) is correct. On question 12, Tired of the back & forth & continued discussions. Needs to be decided as is. Our focus immediately needs to be on stopping the annexation of DHHS, Fernbank ES & Briarvista

ES as suggested by Ken Wan at the UHUMC meeting. We all need to be emailing our legislators, DCS Board members, DCS superintendent to let them know it is our priority to keep the DH school cluster intact. That we will not & do not want City of Atlanta and TIA to annex our HS or 2-ES. Cityhood takes a back seat to this issue. We can push LaVista Hills to remove the LR community from its map when surveys are done.

- For Question 13: But not at the expense of all becoming part of Atlanta. This decision should be made after much much more information, discussion, and time. I'm concerned anytime people are pushing very strongly for their will. To be honest the annexation seems like a group of parents didn't get their way so they want to pack up their toys and leave. This decision affects future parents of DeKalb as well as with students in lower grades that would attend N. Druid Hills. And the new city plan seems like we are just jumping on the "new city" bandwagon. Look -everyone's doing it. It's too early to see what will happen in some of these other new cities. Why not wait and see if that was a good idea before jumping off the cliff. I also believe that working together to improve DeKalb instead of jumping ship is the answer. Besides Atlanta hasn't said all our wants will be granted either. The grass always seems greener doesn't it.
- Assuming (in #s 4&5) that school attendance zones would not change is problematic. As
  parents of young children, maintaining inclusion in the DH high school zone is paramount,
  since there is so much uncertainty remaining in a depleted DeKalb school system. For this
  reason, joining the Atlanta annexation should be strongly considered.
- We have severe mosquito infestation, public health hazard, needs to be addressed.
- Big corporations merge, why would we do the opposite?
- What drives us much like most residents in the area are the quality of education our
  community schools provide for our children as well as balancing our taxes. We don't believe
  becoming a part of Atlanta City Schools is a great option and don't want to be left behind as
  other areas become incorporated. We believe becoming our own city seems like the best
  option but would like more time to make sure we are making an informed decision.
- We lived in Gwinnett County. We researched and deliberately moved into this community and the Druid Hills cluster - because of the school sizes, the diversity, and the nature of the community. I love that my children have schools they can walk to, where teachers live in our same neighborhoods. It sickens me to think that this could be taken away from us. I know DeKalb county has its share of problems, but it is our home.
- I really appreciate all of the information we've been given about all of this. Don't think any of us have as much as we need to make the best decision right now, but we will as time goes on. Would prefer to see DeKalb as reputable as in many years ago. I'm all about less government control & more people driven but would like to think it can be much better. If not, then we can better make alternate decisions.
- Feel like we are being forced into decisions because of a small group. Feel like the community has not been given the chance to even understand the alternatives and consequences much less weigh them. Would welcome more time and more information.
- I agree with Sen. Parent taxes overall WILL go up over time under any cityhood proposal or annexation into an existing city. Adding an additional layer of government (i.e. cityhood) will ALWAYS result in higher taxation over time - governments require tax revenue to exist. Any political promises of lower taxation under cityhood are pipe dreams and/or outright lies. I plan to use my votes to remain unincorporated.
- Our primary concerns are: Property values should not be affected by this process. The whole issue of schools is VERY confusing. If a new city is established, the schools in that district

should be under the jurisdiction of the new city. If for some reason, schools cannot be under the control of the new city, then they should remain under DeKalb Co. jurisdiction. We do not want Atlanta to control our school! or our property taxes and exemptions (i.e. homestead exemptions)

- I cannot believe that our taxes would not increase if another layer of government is added. It seems to take too long for our county leaders to notice unethical or downright dishonest handling of our tax money.
- The motivation for creating these new "cities" seems suspect. Is this people who couldn't get elected to office in DeKalb County carving out fiefdoms for themselves? Is it -- this is ugly, but it needs to be said -- white people who don't like being governed by black people? It's hard to find a logical reason for creating "cities" that have no city-like character and provide only a bare minimum of city-like services depending for everything else on -- who else? DeKalb County!
- Please leave things as they are.
- There are people in the community who seem determined to turn the community into a place like Virginia-Highlands. My community has always been conservative. There are factions who want to turn it more liberal, i.e. diversity, which has been the cause of increased crime in the area, and bringing in, for lack of a better word low-class businesses. Many of us are appalled at the low-end stores & kiosks being allowed to operate at both N. DeKalb & Northlake Malls. These malls are becoming unsafe and many of us are shopping at Perimeter Mall where they have the good sense not to have such stores. I am for cityhood because I believe they share the same conservative values as I do. Just look at the increase in crime around the Northlake Mall, Lavista Rd corridor. And our so-called leaders in the community want to bring in more diversity?? Really?
- To Question 4: You cannot have a city without taxes fees and school assignment-- invalid assumption. I want no part of the City of Atlanta. My observation of living in unincorporated DeKalb since 1961--Less government is better more gov't raises taxes and removes school choice. There is no advantage in becoming a city why not fix the DeKalb County mess and enjoy less gov't cost and meddling (Remember Obama care) Let's not be a sucker.
- Thank you for taking the time and making the effort to put this survey together. Even though I am only renting at this time, I have been a home-owner and I have lived in DeKalb Co. for many years. I am only interested in what is good for the citizens and children of DeKalb County.
- We are anticipating that taxes will rise with the creation of another layer of government. How can they not? It is not like DeKalb Co. would go away. Probably our best option is to remain unincorporated, even though DeKalb Co. is corrupt.
- For question 12: Should or do you mean would/could & for how long?? Political aspirations of a FEW always screw up the lives of many others.
- I know the Atlanta City government and the services it provides. It is corrupt and extremely inefficient. Avoid annexation at all costs. And what would we gain with a new city? At least under the existing unincorporation we know what to expect. Thank you.
- The idea is new to us We need much more information to make an educated judgment.
- I sent my daughter to private school because the public schools were so bad. Until we turn this around it doesn't matter what happens w/annexation, new city, etc.
- Hard to make an informed decision now, with so much uncertain. I do have a fear of being "left behind" in a diminished DeKalb Co.
- The biggest concern for me & my family is the possible loss of our high school. This is more

- important to me than remaining unincorporated, forming a new city or joining Atlanta.
- I would prefer to address the weaknesses of the current situation and not go to the effort and expense of forming a new city which would probably create similar problems and weaknesses. I see no advantage in forming more municipalities which create so much duplicity.
- Question 11: This is such a hypothetical question at this point. Question 12: Not enough research, preparation, etc. has been done to make such a quick & permanent decision. I appreciate this survey but wish more questions besides cityhood questions had been asked. I realize that its the current priority, but gathering feedback about other neighborhood concerns would be helpful ie, crime, lack of sidewalks on LaVista, etc. If we became a new city, would we lose "Decatur" as our mailing address? and become "new city, GA"? I also think getting a PO Box for LRSCA is a good idea so a permanent address is established for all mail/dues in case officers move/change in coming years. Also, being able to sign up/pay dues online would be helpful.
- There is no tangible benefit to citizens with either cityhood or annexation. Indeed annexation
  would devastate DeKalb County. Attention should instead be on supporting the Blueprint for
  DeKalb.
- I don't care for the name LaVista Hills. It doesn't represent where I live. We need more control over local ordinances, for example we need better roads, enforcement of abandoned businesses/homes.
- It is a shame DeKalb breeds corruptness in its government & school systems. As long time residents we would like to see continued exploration with cityhood but with careful consideration & cooperation with all affected communities. We do not want our communities to be, our schools, our neighborhoods to be forked over to Atlanta. DeKalb deserves better, as do our children & their schools.
- New city would tear the heart out of DeKalb County. Services would suffer as seen in Fulton County. If you like corruption and big city politics that are worse than DeKalb - annex into the city of Atlanta. It will be worse. Let new DeKalb leaders show how they are moving forward give DeKalb a chance.
- Thanks for the opportunity to complete this survey. I believe that the desire for a new city is a knee jerk reaction to the allegations regarding corruption. I also want to hear from the new superintendent of DeKalb County schools
